5. Details of step taken to restore normalcy and the impact of the natural calamity on production or service, financials of the company.

At Manapparai - Spinning:

- (a) Ordering of roofing materials and replacement of roof sheet completed within 48 hours.
- (b) Production was affected from 16.11.2018 @7.30AM and restored gradually from 18.11.2018 @10.00AM onwards, bringing the normalicy by 19.11.2018.
- (c) Some power interruption are there which would be normal in a week's time.

At Vedaranium -Salt works:

Currently this is not the season for production. Hence, there is no loss of production. However, dispatch of finished goods is hampered initially for which appropriate steps have been taken to restore it and the same will be operational in a day or two.

We shall submit further updates in the matter in due course. You are requested to kindly take note of the same and disseminate the information on your website.
