We would like to update that above CP is a part of Rs. 100 Crores limit as approved by the Board of Directors in their meeting held on January 21, 2019 and shall be part of the existing working capital limit. We would like to further update that company had already placed commercial paper of Rs. 25 Crs. (due date is 26-09-2019) and necessary intimation was given to Stock Exchange on June 27, 2019. Hence, after placement of above commercial paper, cumulative value of commercial paper stands increased to Rs. 50 Crs.

We would also like to inform that on September 19, 2018, India Ratings & Research had assigned **IND A1+** rating to GHCL Limited for issuance of Commercial Paper of Rs. 100 crores and on September 20, 2018 the Company had filed the necessary intimation to the Stock Exchanges.
