 The above Standalone and consolidated financial results were reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on July 29, 2019. The Statutory Auditors have carried out a limited review of the unaudited Standalone and consolidated financial results of the Company for the quarter ended June 30, 2019, in accordance with Regulation 33 of the SEBI (Listing and Other Disclosure Requirements) Regulations, 2015. The statutory auditors have expressed an unmodified review opinion on these results.

 The Standalone results figures for the quarter ended March 31, 2019 are balancing figures between audited figures in respect of full financial year and the published unaudited year to date figures upto third quarter of the previous financial year, figures upto year end to third quarter were only reviewed and were not subject to audit by the statutory auditors.

3. The consolidated financial result for the quarter ended June 30, 2018 and March 31, 2019, were not subjected to limited review by the statutory auditor of the Company.

4. Effective April 1, 2019 the Company/Group has adopted IND AS 116 'Leases' and applied the same on all lease contracts existing on April 1, 2019 using modified retrospective approach. Under this approach Right-To-Use Asset and corresponding Lease Liability have been recognised at Rs 14.99 Crore as at April 1, 2019. Accordingly the comparatives for the year ended March 31, 2019 have not been retrospectively adjusted. The effect of this adoption is not material to the profit for the current quarter and earnings per share.

5.
