I, CS Manoj Hurkat of M/s Manoj Hurkat & Associates, Practising Company Secretaries, has been appointed as Scrutinizer by the Hon'ble NCLT-Ahmedabad Bench vide order dated 22nd January, 2021 [in CA (CAA) 1 of 2021] to provide assistance to the Chairperson of NCLT Convened Meeting ('the meeting") of Secured Creditors of M/s GHCL Limited ("Company").
